CONDITIONS OF HIRE

The facilities are not supervised, the pool does not have a lifeguard. The Sauna and Fastlane are not monitored.

To ensure that the facilities are used safely it is essential that everyone abides by the rules noted below.

It is the responsibility of the Hirer to make sure that these Rules are observed and the Pool, Sauna and Fastlane are used sensibly and safely. There are guidance notes on who should not use the Sauna in the building and on the website. Everyone should read them to check they are fit to use this facility.

- 1. There must be at least 2 people over 21 in the pool at all times. No more than 8 persons and 2 observers may be in the facility during a hire. Users must not be under the influence of drink or drugs.**
- 2. Children must never be left unattended and are the sole responsibility of accompanying adults.**
- 3. Children's Parties must be organised directly with Jane Jones.**
- 4. No animals, food or drink or glass may be brought onto the property.**
- 5. Everyone must be aware of the Fire Exits as noted on the plan in the building.**
- 6. In emergency use the red telephone in the corridor to dial 999.**
- 7. The pool is 1.1 metres deep and the floors will be wet and slippery. NO DIVING & NO RUNNING.**
- 8. To ensure that we have to use as little Chlorine sanitizer as possible EVERYONE MUST SHOWER before using the Pool and after leaving the Sauna.**
- 9. No shoes may be worn in the pool area, as noted on the pool door.**
- 10. Small children and babies must use appropriate swimwear and nappies.**
- 11. Hirers should provide their own buoyancy equipment. Any equipment borrowed from The Tower House Pool is used at the Hirers risk.**
- 12. The owners do not accept responsibility for hirers belongings brought onto the premises.**
- 13. At the end of the Hire the premises will be left in a clean and tidy condition, as you would expect to find them.**
- 14. Before the Hire commences the Hirer must complete and sign the Hire Agreement Form overleaf. This agreement needs to be renewed every six months; for all intervening visits the hirer register should be signed on poolside.**
